Full Conditions of Sale are displayed in the Sale Area.

Shearing Regulations: ALL sale sheep are Regulation Shorn and Eartagged.

South Australia – that subsequent to last shearing all sheep are inspected and regulation eartagged by two representatives of the SA Stud Merino Sheepbreeders' Association Inc. and deemed to carry not more than 12.5mm of wool as at August 15th 2025 or March 1st 2026.

Interstate – sale sheep are deemed to be shorn, examined and regulation eartagged under their respective States Shearing Regulations.

Mid-Side Sampling

South Australia – samples collected by two independent representatives of the SA Stud Merino Sheepbreeders' Association Inc., between 31st May and 5th June 2026. Laserscan tested by AWTA Ltd., Melbourne Vic week commencing 6th June 2026.

Interstate – samples collected and tested for interstate events and sales such as Bendigo and Dubbo are all AWTA tested.

Inspections: All rams will be available for Inspection in sale pens from 1.00pm on Thursday 10th September 2026 or anytime prior by arrangement with the Vendors or Agents.

Stock Inspector: Will be available on sale day to complete Health Certificates to enable stock to travel to interstate destinations.

Removal of sale rams: All sale and display rams can be removed from the Stud Sheep Pavilion at the conclusion of the sale, with all sheep to vacate the premises by 11.00am Sunday 13th September 2026.

Access to parking within the Showgrounds will be permitted for stock delivery & collection. General parking will be available in the Leader St carpark (fees apply).

TERMS AND CONDITIONS OF AUCTION SALE FOR MERINO RAMS

1. Subject to any reserve price, the highest bidder shall be the Purchaser. Any bidder may retract his bid until such time as the auctioneer announces by the fall of the hammer or otherwise that the lot is sold.
2. In the event of a disputed bid, the auctioneer shall be the sole arbitrator and his decision shall be final. If one of the claimants will advance, then the lot or lots may be put up again at the auctioneer's discretion.
3. The auctioneer may refuse to accept any bid which, in his opinion, is not in the best interests of the Vendor and shall have the right to refuse any such bid without giving any reason therefor.
4. Where the Vendor reserves the right to bid at the auction in respect of a lot and instructs the auctioneer to make more than one bid on his behalf, the auctioneer shall, prior to submitting the lot for sale by auction, announce in a clear and precise manner the number of bids reserved by the Vendor in respect of that lot.
5. A bidder shall be deemed to be a principal unless, prior to bidding, he has given to the auctioneer a copy of a written authority to bid for or on behalf of a person.
6. As soon as practicable after the fall of the hammer, the Purchaser shall sign the agreement (if any) for sale.
7. No person shall be entitled to bid unless prior to the commencement of the sale he has, if requested, made arrangements satisfactory to the selling agent for the payment for any ram which may be sold to him.
8. The purchase money for each ram shall be payable in cash to the Vendor's agent on the fall of the hammer. Delivery shall take place as soon as practicable after the auction. The auctioneer may at anytime before or during the auction require any person wishing to bid for any ram to deposit with him the whole or any part of the auctioneer's estimate of the purchase money.

9. The risk in each ram purchase shall pass to the Purchaser immediately upon the fall of the hammer whereupon the Purchaser shall be responsible for the safety and well being of the same. Property in the ram shall notwithstanding remain with the Vendor until the purchase price has been paid in full. If the Purchaser is given possession of any ram prior to payment of the purchase price, the Purchaser shall be in possession solely as bailee for the Vendor until the purchase price is paid in full and until such time, the Purchaser shall not deal with the ram in any way inconsistent with the title of the Vendor.

10. For so long as any part of the purchase monies shall remain unpaid, the Vendor or his agent shall be at liberty to repossess any ram and for that purpose to enter upon any lands or premises of the Purchaser and to hold that ram at the Purchaser's risk and to resell the same with or without notice by public auction or by private treaty in such manner as the Vendor may determine and the Purchaser shall be liable for all losses and expenses arising out of any such resale and agrees to indemnify the Vendor and the Vendor's agent in respect thereto.

11. All conditions and warranties expressed or implied by law including those created by any statute except the conditions and warranties that may apply pursuant to the provisions of the Competition & Consumer Act 2010 are hereby excluded and subject as aforesaid, each ram is sold with all defects, faults, diseases or imperfections, if any, whether the same may be discoverable by inspection or not and the Vendor shall not in any way be liable for any loss or damage that may arise or result from such defect, fault, disease or imperfection or any error or misdescription of any ram sold or otherwise and no representation made by the auctioneer at the time of the sale shall bind the auctioneer or the Vendor.

ORDER OF SALE

As the saying goes, “You can’t judge a book by its cover”—and likewise, a Ram’s position in the Adelaide Elite Ram Sale should not be seen as a reflection of its quality. Exceptional Rams are featured throughout the entire catalogue, with sale order determined by a range of factors.

For Studs that participated in the previous year’s Adelaide Sale, their 2026 sale position is based on the average of their top three sale prices from 2025. The Stud with the highest average begins the current sale.

Examples:

- Stud A sold two Rams in 2025 for \$10,000 and \$15,000. Their average is calculated as \$8,334 ($\$25,000 \div 3$).*
- Stud B sold three Rams for \$5,000 each. Their average is \$5,000 ($\$15,000 \div 3$).*
- Stud C sold five Rams for \$9,000, \$10,000, \$12,000, \$5,000, and \$5,000. The average is calculated using the top three prices: $\$31,000 \div 3 = \$10,334$.*
